#### **Membership Details**

- -Adult Memberships: 7-day play during available tee times.
- -Add a Spouse If a spouse is added to a membership, the rules of that membership apply to that spouse.
- -Weekday Membership: Monday to Friday during available tee times.
- -Twilight Member: 7-day play after 3 pm. Changes Seasonally.
- **-Prime Member:** 7-day play during available tee times. Must not reach their 36<sup>th</sup> birthday before May 1<sup>st</sup>, 2025.
- **-Intermediate Member:** 7-day play during available tee times. Must not reach their 26<sup>th</sup> birthday before May 1<sup>st</sup>, 2025.
- **-Junior Member:** 7-day play during available tee times. Must not reach their  $19^{th}$  birthday on or before August  $16^{th}$ , 2025.
- **-Member Discounts**: All members are eligible for a 15% discount on all apparel and 10% on any hard goods. Does not include previously discounted items or apply with other discounts.

#### **Rules and Conditions**

#### **Payment Conditions**

- Payment plan for membership will be automatically paid monthly by credit card or post-dated cheques.
- An administration fee of \$49 will be added for all payment plans.
- Eagle Crest reserves the right to suspend memberships if not paid in full by June 30<sup>th</sup>, 2025.
- All House Accounts with Eagle Crest must have a valid credit card on file and agree to automatic monthly billing.
- House Accounts must be paid in full by October 31<sup>st</sup>, 2025. Eagle Crest reserves the right to charge account balance to credit card on file if not paid in full by October 31<sup>st</sup>, 2025.

#### **General Regulations**

- The opening and closing of the golfing season shall be at the discretion of management.
- Persons found damaging course property or equipment may have golf privileges suspended immediately.
- Personal property brought onto course property is solely at the risk of the person, and the course shall not be responsible or liable to the member/ or guest for any loss thereof or damage thereto.
- Members and guests are responsible for any damages to power carts.
- Power cart use may be totally or partially restricted due to inclement weather at the discretion of management.
- Due to limited availability, power carts must be shared with others. No more than two power carts will be
  permitted per group. As cart packages are priced per seat, Eagle Crest reserves the right to rent the other
  seat on a single rider's power cart unless both seats are purchased.
- No member or guest shall bring outside alcohol on the premises. Eagle Crest reserves the right to revoke golf privileges if personal alcohol is brought onto the property.
- Golf attire must be adhered to at all times.
- Members shall not be permitted to utilize the facilities when the course is closed, unless approved by management.

#### **Rules of Play**

- All players must register in the pro shop prior to playing. Incomplete foursomes may be filled.
- Pace of play must be adhered to at all times. Players failing to maintain the pace of play by falling behind more than one clear hole from those in front, must wave the following group through.
- Failure to cancel unused tee times or update the number of golfers may result in the suspension of membership.
- Players must not start on the 10<sup>th</sup> tee without permission from the pro shop staff.
- There is no guarantee of tee time availability.

- Golfers playing before tee times must not interfere with maintenance staff as they have priority during this time.
- All power carts must be returned to the pro shop before dusk.

### **Turf Care Regulations**

- Replace divots. Repair ball marks on greens. Rake sand traps.
- Be cautious with flagpoles on greens and avoid causing turf damage with practice swings.
- Keep power carts at least 30 feet from the greens and travel on cart paths or in the rough whenever possible.
- Do not use bug spray on grass, especially on tees and greens, as it causes turf damage.
- Range balls are for driving range use only. Removing balls from range may result in loss of range privileges.
